About the position

We are looking for a Financial Controller, who will supervise the accounting processes and be responsible for the Financial Planning and Analysis of our organization.

Key Accountabilities

- Reporting:
 - o With the help of one internal accountant and external CPA ensure the quality and precision of accounting data and analytical information
 - Work closely with functional directors to analyse their data, understand their performance and challenge their perspectives as well as to support in assessing and managing the performance of their areas
 - o Provide accounting & analytical support to 6 subsidiaries across Europe
 - O Demonstrate ability to analyse and understand business models and organizations to understand their financial support needs
 - Being the main reference for internal & external auditors
- Budgeting/Planning:
 - o Prepare and coordinate the budget process in close collaboration with the Finance Director and the members of the Management team
 - o Preparation and analysis of quarterly forecasts
- Projects, Finance projects and tools
 - Support EIT Manufacturing Management team, especially with regards to external project management, communication with external project partners, analysis of questions pertaining to cost eligibility regulations and support for external contracting.
 - Collaborate with the Finance Director in order to provide guidance to the project partners and to support the multi annual elaboration of the EIT Manufacturing Business Plan as well as the regular reports





- Monitor the use of the funds by EIT Manufacturing projects via sampling and testing of costs reported according to the EIT Manufacturing projects monitoring processes, collaborating with the PMO that is in charge of the overall monitoring process
- o Contribute to the ongoing implementation and administration of management tools (e.g. the implementation of the ERP, the management control tools, load and monitor consolidation data)
- Animate the community of budget correspondents (e.g. training in management tools, the Procurement/ Commitment process, and the budgetary process)
- Act as a Business partner to the Management team
- Have experience in start-up, scale up, multicultural and international environment

Qualifications:

- Master's degree in the relevant field, complemented with Project Management degree and/or relevant practical experience
- Minimum of 5-7 years experience in similar roles

Skills and expertise:

- Strong business acumen and understanding of Finance
- Able to drive transparency and simplicity in complex administrative and business process
- A team player who understands the importance of the team work in an international, challenging and ambitious environment
