About the Co-location-Centre (CLC) South East

The CLC South East is an integral part of the governance of EIT Manufacturing, a Knowledge and Innovation Community (KIC) and fosters connectivity with local ecosystems through the provision of physical spaces for interaction. It initiates, hosts and implements the various KIC's activities and provides a platform for discussion of innovative ideas. The CLC South East identifies and builds new possibilities to further substantiate the KIC's long-term sustainability and are actively involved in helping to secure funding for Innovation, Education and Business Creation activities. The CLC South East also identifies and exploits promising opportunities for cross-CLC activities.

About the Regional Innovation Scheme (RIS):

The EIT Regional Innovation Scheme constitutes an integral part of EIT Manufacturing's strategy and is designed as a long-term initiative to strengthen the national and regional innovation eco-systems of countries that are moderate and modest innovators by transferring good practices and know-how to boost innovation.

Currently, EIT RIS eligible countries are the following:

- EU Member States: Bulgaria, Croatia, Cyprus, Czech Republic, Estonia, Greece, Hungary, Italy, Latvia, Lithuania, Malta, Poland, Portugal, Slovakia, Slovenia, Spain, Romania
- Third countries: Montenegro, North Macedonia, Serbia, Turkey and Ukraine. These third countries, which are all listed in the European Innovation Scoreboard, will be fully eligible for the EIT RIS, following the successful conclusion of individual Horizon Europe Association Agreements.
- Outermost Regions: Guadeloupe, French Guiana, Réunion, Martinique, Mayotte and Saint-Martin (France), the Azores and Madeira (Portugal), and the Canary Islands (Spain).

A primary objective of EIT Manufacturing is to establish a stable innovation ecosystem in EIT RIS countries that will be directly and closely linked with EIT Manufacturing. Towards this purpose, EIT Manufacturing will implement a range of activities engaging individuals (e.g. students, researchers, manufacturing workforce) and entities (e.g. manufacturing companies, especially SMEs, start-ups, scale-ups, universities, research institutes, etc) within the context of the EIT Regional Innovation Scheme. EIT Knowledge Triangle Integration in all three main areas, Innovation, Education and Business Creation will be promoted and facilitated. Accordingly, it is crucial that our RIS portfolio is monitored, supported and steered towards accomplishing the strategic objectives of our community.





About the position

The selected applicant will be responsible for identifying regional and national initiatives in EIT RIS eligible countries of CLC South East and beyond, realizing fruitful collaborations of CLC South East and EIT Manufacturing in general with these initiatives, including exploring the possibilities for attracting funding. He/she will strongly engage suitable regional and national stakeholders from the relevant countries, raise awareness of EIT Manufacturing and materialize concrete synergies and joint initiatives with regional/national authorities.

Key Accountabilities

- Implement the relevant activities effectively
- Take an active part in the project development
- Work closely with the EIT Manufacturing's Director of EU Affairs and RIS, the director of EIT Manufacturing CLC South East with partners and/or external stakeholders and outline strategies to accomplish the relevant objectives
- Be proactive and and identify corrective actions
- Take appropriate actions and measures to achieve the objectives and targets (e.g. KPIs) of the project
- Prepare all relevant documentations (deliverables, collaborations planning, MoUs, MoCs, performance and cost reporting, KPIs, etc)
- Facilitate also the development of the EIT Manufacturing RIS programme in general and the operations of EIT Manufacturing CLC South East
- Organize workshops, meetings and dissemination events with the relevant regional/national authorities

Qualifications:

- University degree in relevant field
- Minimum of 3 years experience in relevant and similar tasks
- Demonstrated network in governmental institutions for relevant regions/countries

- Experience in the relevant fields such as ecosystem creation, acceleration programmes, entrepreneurship, engagement of individuals for innovation, incubation, networking, etc.
- Good knowledge of regional and national programmes, initiatives and strategies
- Process-oriented with attention to detail and ability to best combine analytical thinking with creativity in order to develop joint initiatives with regional/national authorities.
- Report writing. Excellent command of the English language is mandatory.
